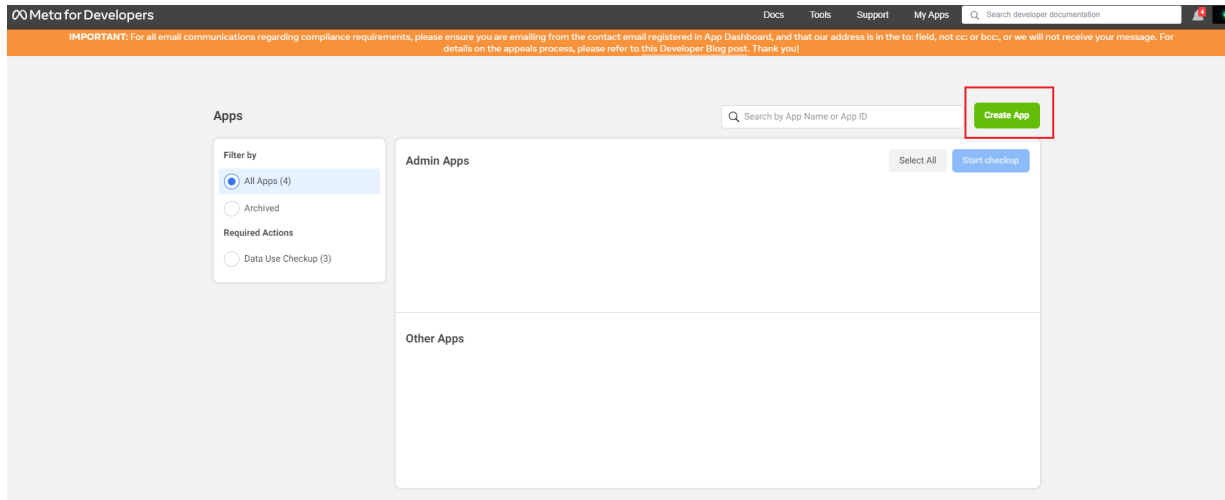


Create Facebook Application to set up login

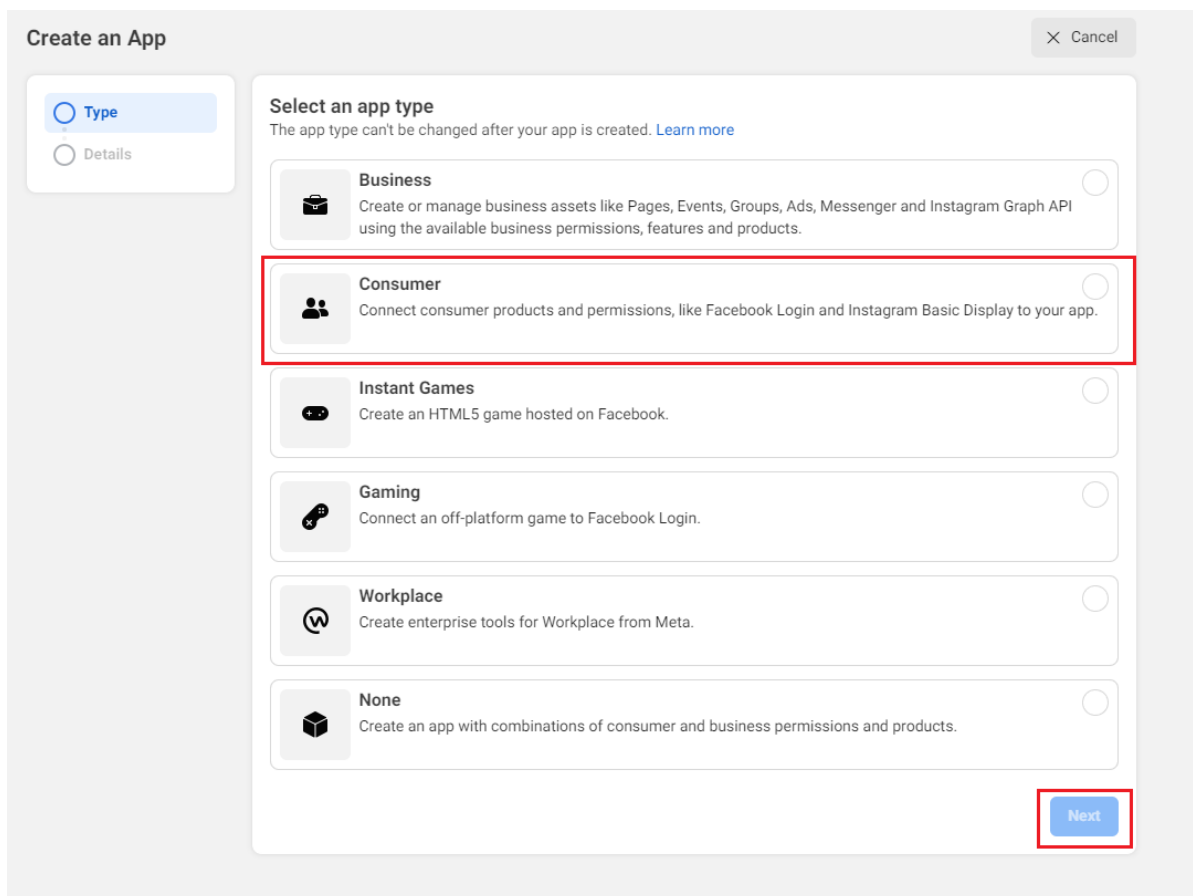


Use the link https://developers.facebook.com/apps/?show_reminder=true to set up and configure application.
